2. Contractor have to Get Third Party Approval for their submitted design from Specified Third Party Authority. Additional time limit will not allow for the same.
3. Bidder Have to Take All Govt. Approvals & Connections like Fire, Electricity, Plumbing, Drainage etc. Client Will pay or Reimburse only official charges of Govt. Liasioning for All liabilities in Bidder Scope. Rajjaa Chithhi and BU Permission shall be done by Client. Contractor shall arrange all other noc for Fire, Lift and Electrical.
