IV. Terms & Conditions:

1. A seat in the training will be reserved only upon receipt of training registration form accompanied by training fee.
2. The seats for the training will be filled on a first-come-first-served basis.
3. **Additional Aid:** (a) All participants have to **bring their own laptop with pre-installed PV*SOL trial version** to effectively undertake the software training. Neither laptop nor the PV*SOL software will be provided in the training. (b) Participants should have prior knowledge of solar PV systems and its design parameters.
4. **Event Cancellation:** GERMI reserves the right to cancel or re-schedule the training with a 7 days' notice. In the event of such cancellation, participants may opt to have the pre-paid fees refunded in full.
5. **Participant Cancellation:** In the event of participant cancellation, only 50% of the course fees shall be refunded, provided at least 7 days notice is given prior to training commencement. No refunds will be given in respect to participants' cancellations received less than 7 days prior to commencement of the scheduled training.
